On January 1st, 2023, I Deputy Brian L. Yoder #1340 was working patrol related functions in a Franklin County Sheriff's Office marked cruiser #34 while in the uniform of the day.

At approximately 0235 hours, the Franklin County Sheriff's Communications Center aired that a shooting had occurred with multiple victims at 2830 Johnstown Road, 43219, Columbus, OH (Buck's Platinum in Mifflin Township).

At approximately 0239 hours, I along with Clinton Township Police Officer J. Goodwin arrived on scene of the above listed location. Upon entering the establishment, there where multiple individuals screaming and running about with broken glass, broken chairs, and tables flipped in multiple locations. Walking through the threshold of the door to the main lounge, there was an unconscious male black lying on the floor with serval patrons surrounding him attempting to give aid. Officer Goodwin immediately began to administer male later identify as Charles Westbrook (OLN: After assuring that Officer Goodwin was good working alone, I proceeded further into the lounge to locate more victims.

Division Of Police respond to help with crowd control and	containment of witnesses.

I then went back to Mr. Smith and assessed his injury, he had suffered a gunshot wound to his left foot and it appeared that the he had an entrance and exit wound from the gunshot. At this time medical personnel had arrived and began to treat Mr. Smith. I began to write down Mr. Smith's personal information when he informed me that his brother James Littlejohn Jr (OLN: had also suffered a gunshot wound to his foot and had been taken by friends in their personal vehicle to Grant Hospital. I requested that the communications center contact Grant

Medical Center and inquire about possible walk in victims with gunshot wounds, to which they later replied that there had been multiple victims walk in to various local hospitals.

After all victims were taken out of the lounge by medical personnel, I proceeded outside of the establishment and made contact with Sergeant Detective M. Casper where I briefed him on what was occurring inside. While walking out of the building a Columbus Police female officer had informed me that a Hispanic male that was of a heavier build had witnessed the crime occur and stated he had video footage on his cellphone. I then made contact with the male later identified as Gregorio Canchola (OLN:

I proceeded back into the establishment where Clinton Township Officer C. Hughes and myself began to rope off the primary crime scene with crime scene tape. Due to the large amount of patrons that were possibly witnesses to the crime still inside and knowing that if they were to exit the establishment that they would potentially leave, we did the best we could at securing the most vital scene of the crime. Still allowing those who were possible witnesses to hangout in the halls, VIP rooms, and dressing room while waiting to speak with a detective.

At approximately 0422 hours, Sergeant J. Sommer informed me that Mr. Canchola had been secured in my cruiser by another deputy and that H.

Sommer relieved me from my position providing scene security and I proceeded to my cruiser where I patted down Mr. Canchola prior to transport. During transport Mr. Canchola was on the telephone with a female and kept making spontaneous utterances referring "the African American males who had done the shooting". Watshquard video (audio was continued from the

telephone with a female and kept making spontaneous utterances referring "the African American males who had done the shooting". Watchguard video/audio was captured from the time that I arrived on scene until I arrived at the detective bureau, capturing the transport when Mr. Canchola was making the utterances. The video/audio recording was saved in cruiser #34 and saved under the CAD to this incident which is #23-00188.

On January 1, 2023, I Deputy Cody Corrova #1456 was assigned to Franklin County Sheriff's Office Patrol car 22, working in marked cruiser 23 in the uniform if the day. At approximately 0235, I was dispatched to a report of a shooting at Buck's Platinum, located at 2830 Johnstown Rd. Dispatchers advised that callers reported multiple victims were shot at this location.

Upon arrival at approximately 0240, multiple officers were already on scene. I entered the front door of Buck's Platinum and observed a male black, later identified as Charles Westbrook (hereinafter Westbrook), laying on the floor at the entrance to the showroom from the front hallway entry. Westbrook appeared to be rendering aid to Westbrook and I began searching the building for other victims. Officers were rendering aid to another victim on the southwest side of the dance stage who had been shot in the foot. I then located a female white employee who is a dancer that was shot in her upper left arm, which Officers had already and found no other victims inside.

After all victims were with medics, I began attempting to secure the scene and witnesses. There was still a large amount of employees and customers inside the building and outside in the parking lot. I assisted with taping off the inside, around the stage area, where the shooting had apparently taken place. We secured as many witnesses as possible but had limited space inside and outside of the building.

later identified as Erick Munguia (DOB 10-17-1994), was acting disorderly at the front entrance of the building. I detained him and placed in the rear of marked cruiser 23. I activated my watch guard cruiser camera as soon as Erick was placed inside. As I was placing Erick in my cruiser, he began stating that his 16 year old brother was inside the building at the time of the shooting and

had video of the incident on his cell phone. Other Deputies located Erick's brother and secured him in the rear of FCSO cruiser 34. Erick stated that he also witnessed the shooting take place and could identify the suspect.

I started a crime scene log and began to have all officers on scene sign in to the log while trying to maintain the security of the crime scene.

On 01/01/2023 at 02:36 hrs, units were dispatched to 2830 Johnstown Rd. (Bucks Platinum) for shots fired. Dispatch advised there were multiple victims and no suspect information.

Prior to my arrival, Officer Goodwin from Clinton TWP advised there were a lot of victims needing first aid. I arrived on the scene at 02:41 hrs. When I first walked in the door, I noticed a group of individuals on the floor surrounding a black male who was

We loaded the victim into the back of Mifflin Medic 134 and transported him to Grant

Medical center. Once on scene, doctors and medical staff began tending to him. They

pronounced him dead at 03:16 hrs. At this time, 2 Franklin County Deputies arrived at Grant to
relieve me.

Due to the magnitude of the situation and not finding an ID on the black male, I was not able to identify him. This incident was captured on Minerva Park Body Camera 3270 and taken over by Franklin County Detectives.

On January 1, 2023, I, Deputy T. Curren #1373 was assigned to, Franklin County Sheriff's Office marked cruiser #20 and wearing the uniform of the day.

At approximately 0235 hours a toned-out dispatch run for a shooting at 2830 Johnstown Rd (Bucks Platinum Gentlemen's Club). At this time, Multiple units marked in route to the scene. While in route we were update from dispatch that there had been multiple victims shot, one in the foot and one in the neck. It was also aired that on a victim. Upon my arrival with other units already on scene and inside of the building, I immediately exited my cruiser and retrieved three medical kits from the rear of the cruiser. I then proceeded to the front door making entry. Once inside I proceeded through the lobby and made my way into the main area of the building. I observed a male who was later identified as Charles Westbrook lying on the floor in the prone position with a female this time, Clinton Twp. Officer J. Goodwin #60 asked what was needed and was advised that they needed Mr. Westbrook's clothing removed. At this time, I used my trauma sheers to cut Mr. Westbrook's t-shirt and pants off. I observed a small gunshot wound to the upper abdomen of Mr. Westbrook. Once the clothing was removed several officers continued lifesaving measures for Mr. Westbrook and I then proceeded to the assist with the next victim who appeared to have been suffering from a gunshot wound to his foot. The officer who was treating this victim stated they were good, and I was advised by an unknown witness that another victim may have been in the back room or in the rear of the building. At this time, I proceeded to the backroom area where I cleared the room for potential suspect(s) and victims. Once the room was clear I exited out of the rear emergency exit and began looking in that area for suspect(s) or victims. While searching the area along with Deputy J. Fowler #1464 I observed a tan colored AR-15 style rifle on the ground next to the dumpster which was surrounded by a cinder block wall. At this time I aired that a 40 had been found along with its location, Deputy Fowler agreed to stay with the firearm and secure the area and I proceeded back inside to assist with rendering aid. Once back inside I proceeded back over to

where Mr. Westbrook was still lying. I then on Mr. Westbrooks abdomen and when we rolled him onto his side, we were able to observe a possible exit wound on his upper back. At this time, I

Medics had arrived on scene and were ready to transport Mr. Westbrook. Myself, several other officers and medics lifted Mr. Westbrook onto the gurney where medics removed him from the scene and transported him to a local hospital. As I was gathering the medical kits I brought in I observed a female exit from a bathroom area with a gunshot wound to her upper arm that appeared to have been treated and she was being escorted out of the building by medics.

I returned to the cruiser and moved it through the parking lot and back to the area of the dumpster where Deputy Fowler was at along with the firearm. Deputy Fowler and I then began using the crime scene tape to block off the area surrounding the dumpster. As we were taping off the area, I then observe a handgun lying on the ground in front of the right rear wheel of a dark colored Hyundai. The pistol appeared to be a Glock 43 with an opaque blue extended magazine. I then aired that a second 40 had been located on the westside of the building and provided the plate number to the vehicle. Deputy Fowler and I then continued to tape off the area surrounding the pistol. I then proceeded to find a blood trail leading from the northwest corner of the building in between two vehicles. The blood trail started off with small droplets leading southbound through the parking lot where they ended with a significant pool of blood. I also observed what appeared to be a smeared handprint on the driver side door on a dark colored dodge car. Once BCI arrived on scene and made there was to the area I was in I advised them of where everything I discovered was.

I continued to maintain scene security of the firearms and blood until all evidence had been collected and BCI agents stated I was clear to leave.

On 1-01-2023 I, Deputy Jacob Fowler #1464, was assigned to the patrol division of the Franklin County Sheriff's Office. I was in uniform of the day and assigned to marked patrol car #23.

At 0235 Am there was a toned out dispatch to 2830 Johnstown RD, Bucks Platinum, on the report of a shooting with multiple victims hit. When I arrived on scene I entered through the front door. Upon entry I saw one of the victims laying on the floor with multiple officers giving aid to his wounds. The club was still in chaos with a large amount of entertainers and customers running around. I continued through the club and observed one of the victims, a black male, who had been hit in the foot. I stayed with him and a Clinton Township officer and assisted with aiding to his wound. While assisting there a female came from the back yelling that someone was hit outside in the rear of the building. The Clinton Officer said that he was good and Deputy Curren and Myself exited the rear of the business.

I exited the rear of the building and began asking where the victim was and searching the parking lot. No one outside had been hit. Deputy Curren and I began searching the parking lot for other victims or possible suspects. While searching the parking lot Deputy Curren located what appeared to be a tan AR pistol on the side of the dumpster located out back of the business. Due to the number of people on scene outside of the business, I agreed to stay with the weapon to secure the scene and ensure the weapon was not tampered with and would not be a threat to anyone. Deputy Curren returned inside of the business.

Deputy Curren returned back to my location with weapon once victims had been transported by medics and we had better control of the scene with witness's. Upon his arrival we used crime scene tape to secure the area where the weapon was located. Once the area was secured we began searching the parking lot further.

While searching the parking lot we located another weapon. This weapon was located in the grass by the tire of a blue in color Hyundai SUV. It appeared to be a sub compact Glock black in color with some type of extended magazine. Again Deputy Curren and myself secured this are with crime scene tape. We then both stayed with the weapons and secured the scene. I stayed in this position until I was relived by BCI. I was then needed at the front of the business.

I then went to the front of the building and took control of the crime scene log. While standing at the front door I was in charge of ensuring the anyone entering the scene had a law

enforcement escort, as there was still a large number of employees, entertainers, and customers who needed to speak with the Detectives on scene. I stayed in this position until I was relieved by A company Deputies.

On 1/1/2023 at 0235 I responded to a shooting at 2830 Johnstown Rd. Upon my arrival there were 20-30 people outside of Bucks Platinum, I saw officers in front of the building and officers back by the dumpster in the rear of the building. I checked the rear of the building first, Officers and Deputies told me they had located a weapon. I instructed them to stay with the weapon and I then went inside Bucks Platinum.

Once inside there were 30-40 people and what appeared to be a male on the floor with several officers. I then exited the building to bring in the medics. As medics arrived I escorted them into the building and they took over life saving measures. As more medics arrived I informed they that we had several people shot inside.

As the medics started to leave the scene with victims I aired to the radio room the medic number and where they were taking the victim. Once all the medics cleared Sgt. Casper and Sgt. Kirby arrived on scene and I informed them of information I currently had. Deputies were dispatched to the hospitals to follow up with the victims and get their information.

The scene was secured the best we could with the resources that we had. As the detectives started to interview witnesses two individuals were taken into custody as they were causing a disturbance. I then remained outside of Buck Platinum

After approximately 1 hour from my arrival

I then relieved Deputy Yoder from inside Bucks Platinum as scene security I

On January 1, 2023, I wore the day's uniform and worked as L3. I heard a shooting call go out at Bucks Platinum located at 2830 Johnstown Road Columbus Ohio, 43219. I monitored radio traffic until Sergeant J. Sommer and deputies arrived on the scene. Deputies on scene advised communications that there were multiple shooting victims and to send the medics in.

I heard shooting victims being transported to Grant Hospital, OSU East Hospital, and Mt. Carmel East Hospital. I asked via the radio if law enforcement was being sent with shooting victims to the hospitals. The scene was active, and law enforcement was trying to control patrons, secure evidence, and assist medics safely entering the scene to tend to victims, so no law enforcement was following medics with victims.

I marked en route to Mt. Carmel East for two victims that were shot at Bucks Platinum. I had communications dispatch deputies to Grant Hospital and OSU East for the remaining shooting victims. After arriving at Mt. Carmel East ER, Columbus Police were on the scene. Columbus Police were with the driver of the male victim. I asked Columbus Police to remain with the driver until I could get another county unit to Mt. Carmel East Hospital. Deputy S. Brintlinger arrived at Mt. Carmel East Hospital and stayed with the driver of the male victim until Detectives J. Thompson and S. Greenburg arrived to interview him.

Both shooting victims were in the trauma center when I arrived at Mt. Carmel East Hospital.

The female victim was treated and taken to bed 42 in th ER. The male victim had an initial assessment and was

The female was shot one or two times in her upper left arm and the male victim was shot approximately five times in his lower extremities.

The female victim was freely speaking with Deputy C. Brintlinger (after arriving at Mt. Carmel East Hospital) and me while she was in bed 42 at Mt. Carmel Eas ER. The female victim said she was trying to break up a fight inside Bucks Platinum. The female victim said a black male was beating another patron with a beer bottle. The female victim said she tried to pull the primary aggressor off after she thought he was trying to kill him. The female victim said she was shot by an unknown person while trying to break the fight up.

Note: The female victim was Ms. Autumn Eckman and is an employee of Bucks Platinum. The male victim was Omar Jama.

After being relieved from Mt. Carmel East Hospital by Deputies S. Brintlinger and C. Brintlinger, I marked en route to Bucks Platnium. After arriving at Bucks Platinum I assisted deputies and detectives with the scene until relieved.

On January 1, 2023 I, Deputy Dennis Coyne #82, was assigned to FCSO Patrol Car 24 from hours 0300 to 0700. At 0234hrs a shooting occurred at 2830 Johnstown Rd (Bucks Platinum).

I was advised to start to Grant Hospital where two of the victims were taken for their injuries. Once on scene, I learned that one of the victims, Charles Westbrook (04/29/1994) had died from his injuries at 0316hrs. Deputy Davis sat with Mr. Westbrook in the morgue while I sat with the other victim, James Littlejohn (12/10/1987) in ER #42.

Mr. Littlejohn had one gunshot wound to his right foot and was advised by CPD Sgt. Mason that Mr. Littlejohn was brought to Grant Hospital by his brother, Shawn Thomas (11/19/1986) who CPD had detained outside of the Hospital along with his vehicle bearing OH registration Q127989 in the parking garage across from Grant Hospital.
